2024-25 ANNUAL WY-JON COUNTY USBC MEMBERSHIP SENIOR TOURNAMENT RULES

1. All Participants entering in this tournament MUST be a WY-JON County USBC member prior to the start of competition. Memberships can be purchased the day of the tournament.
2. This is a SENIORS event and all participants must be 50 years or older in age the day of the tournament.
3. Entrants shall use their highest USBC certified league average of 21+ games on bowl.com from the 2023-24 season. If no certified league average of 21+ games from the previous season, the bowler may use the current season average if 21+ games have been bowled as long as a current league sheet is provided for verification. If bowler has neither of the acceptable averages listed they will be required to use a 220 average. There will not be a 10 pin rule in effect for this tournament. Team Captains are required to complete all averages on the front of the entry form.
4. It is the responsibility of the bowler to verify their average prior to commencement of competition or be subject to disqualification.
5. Entrants entering the Doubles event must also enter the Singles event and vice versa. Doubles & Singles events will be bowled on the same pair of lanes with the Doubles event bowling first. Entrants may bowl the Doubles event twice but must change partners to bowl a second time. Entrants may cash on multiple entries. The first bowled doubles event counts towards All-Events score. Entrants may only bowl the Singles event once.
6. No entry applications will be accepted unless accompanied by the required entry fees.
7. You agree to abide by all tournament rules and USBC regulations governing tournament competition. You also warrant that you are USBC members in good standing and will bowl on the lanes assigned to you.
8. In the event of mechanical failure, it is hereby agreed that bowlers affected shall be moved to the next available pair of lanes in the center.
9. Each individual bowler is held responsible for rules violations. Any entrant appearing at his/her scheduled time of bowling who appears to be under the influence of intoxicating liquors, or any entrant who willfully delays the normal progress of the game, or any entrant whose conduct on the lanes is considered objectionable, shall be disqualified and immediately removed from the lanes, regardless whether a qualified substitute is available or not.
10. All entrants will be handicapped 90% of the difference between their series average and 660.
11. Payout Ratio: At least 1 out of every 6 entries for Singles & Doubles will cash in this tournament. At least 1 out of every 10 entries for the Handicap & Scratch All Events will cash in this tournament. Prize funds will be distributed within 30 days after the conclusion of the tournament.
12. Original score sheets are official and obvious errors are subject to change and correction by the tournament director. All protests concerning errors in scoring or errors in calculation must be made in writing within 24 hours after the conclusion of the event.
13. Lanes will be oiled before each squad.
14. Any rules not covered specifically by these rules will be governed by USBC rules.
15. All entries are due in the Wy-Jon County USBC office (address is on the front of this form) by 5:00 pm, Wednesday, March 12th, 2025. Walk-In entries the day of the tournament will be charged a \$5 late fee per bowler per event. Walk-ins will be allowed up to an hour prior to each squad time. This will be subject to availability!
